

AMENDMENT OF WATER AND SEWER AGREEMENT
GEORGETOWN CHARTER TOWNSHIP AND CITY OF HUDSONVILLE
40TH AVE AND BARRY ST.

THIS AMENDMENT, made and entered into this 12th day of OCTOBER, 1994, by and between GEORGETOWN CHARTER TOWNSHIP, hereinafter referred to as "Georgetown", and the CITY OF HUDSONVILLE, hereinafter referred to as "Hudsonville", both Michigan Municipal Corporations of Ottawa County, Michigan, as follows:

WHEREAS, the parties have previously entered into a certain water and sewer agreement dated May 1, 1977, and certain supplemental water and sewer agreement dated May 12, 1980 and June 8, 1982; and

WHEREAS, Georgetown provides water service on 40th Ave, hereinafter referred to as the "Georgetown 40th Ave System", and

WHEREAS, Hudsonville provides sewer service on 40th Ave, hereinafter referred to as the "Hudsonville 40th Ave System", and

WHEREAS, Hudsonville provides water and sewer service on Barry St., hereinafter referred to as the "Hudsonville Barry St. System", and

WHEREAS, the parties do not wish to duplicate service, and believe it is in the best interest of both parties if the residents of one municipal corporation should bill the customers on both sides of 40th Ave. and reimburse the other.

THEREFORE, IT IS AGREED AS FOLLOWS: Georgetown shall bill all customers using the "Georgetown 40th Ave. System" and the "Hudsonville 40th Ave System" within Hudsonville at the Hudsonville Rates. Georgetown residents using the "Hudsonville 40th Ave. System" will pay Georgetown rates. Georgetown shall pay to the Hudsonville the amount collected for sewer service without administration fees. The amount shall be paid annually by January 31 for the previous year.

IT IS ALSO AGREED THAT Hudsonville shall bill and retain receipts from all customers using the "Hudsonville Barry St. System" within Georgetown at the Georgetown Rates.

All other term, conditions and provisions of previous Agreements are not effected by this amendment, and are hereby ratified and confirmed and shall remain in full force and effect.
